The enrollee understands that there is a risk of personal injury involved in said course of instruction and with this knowledge agrees to indemnify and save harmless the Center from all losses caused by accident or injury to the enrollee or to third persons who may be enrollees by the Center, in the event that either the enrollee or said third person is injured in any way during the proper performance and execution of martial arts instruction. Because of the physical demands of martial arts instruction, enrollee understands that he or she must be in good physical condition to participate in said instruction and hereby certifies that he or she is in good physical condition. I pledge never to use the knowledge gained at this Center except to protect the well being of the defenseless of myself. I, the undersigned, upon being permitted to join, will obey the rules, and will endeavor to conduct myself in a manner of a student in my daily life and in class, and will never do anything to bring disgrace upon the Center. I understand and accept that I may be photographed or videotaped during class, testing etc., for advertisements, commercials, etc. for the use of the Center. ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO

CORONAVIRUS/COVID-19

This Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID-19 is an amendment to the Activity Waiver between YOON'S MARTIAL ARTS (hereinafter referred to as "the Club") and Buyer and Student(s) listed below. It is not meant to supplant the Activity Waiver. All terms and conditions of the Activity Waiver remain in full force.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Club has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that Buyer or their Student(s) will not become infected with COVID-19. Further, attending the Club could increase Buyer's risk and Student(s)' risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that Buyer and Student(s) may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions or omissions, of myself (the Buyer), the Student(s), and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to Student(s) or myself (Buyer), including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind (including attorney's fees, court costs, and disbursements), that Buyer or Student(s) may experience or incur in connection with Student(s)' attendance at the Club or participation in Club programming ("Claims"). On my behalf, and on behalf of Student(s), I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions or omissions of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program. The provisions of this section will continue in full force and effect even after termination of the Membership Agreement.

★ STUDENT RULES AND REGULATIONS FOR PARENTS AND KIDS TO GO OVER ★

1. No cellphones are allowed to be out unless it is being used for an emergency, electronics day on Friday, or with permission.
2. Proper attire including a Yoon's Summer Camp shirt and something comfortable for the child(ren) to exercise in must be worn. Students must wear camp shirts every day of camp.
No jeans, sandals, or flip-flops. Socks and shoes only for mat and outdoor play.
3. **Never touch another student without permission.**
4. **Provide an extra change of clothes.** All items including clothing, toys, etc. must be kept in a bag.
5. Bring a water bottle with the child's name.
6. No video games, movies, toys etc. are permitted without permission.
7. No abusive/inappropriate language or horseplay is allowed.
8. Yoon's Martial Arts staff is not responsible for lost or stolen items. Please write your child(ren)'s name on their belongings to prevent this.
9. **Proper hygiene must be maintained daily (including feet). *VERY IMPORTANT***
10. No jewelry.
11. All injuries should be reported to the staff immediately.
12. Students may only leave with an authorized adult. A valid ID is required.
13. Students who do not meet self-discipline standards will be unable to participate in activities.
